## **Release and Indemnification Agreement**

In exchange for Green Bay Packers, Inc. ("Event Sponsor"), offering space and equipment at **Lambeau Field** to those taking part in all activities offered as part of the **Green Bay Packers 5K Run** (collectively the "Activity") as well as other good and valuable consideration, the undersigned participant or minor participant by and through his or her parents or guardians (collectively the "Participant") agrees to release and indemnify Event Sponsor from any injuries or accidents he or she may suffer as a result of the Activity, as well as from any and all other claims related to The Activity.

### **Understanding of Risks**

Participant understands and acknowledges that there are serious risks associated with this Activity including but not limited to risks related to running, such as slipping and falling and/or colliding with other participants, aggravation of existing injuries, weather effects, terrain condition variation, unpredictable spectators/participants, natural and man-made obstacles, etc. I acknowledge that it is my responsibility to understand the risks associated with participating in the Event and determine whether Participant is fit to safely complete the Event and the precautions a Participant should take. I attest and certify that Participant's physical condition and ability to safely complete the Activity have been verified by a licensed medical doctor (except where the latter is in violation of religious principles); and that Participant is physically fit and has sufficiently trained to complete the Activity. I also acknowledge the possibility that an Activity may be postponed, ended early or cancelled altogether by Event Sponsor. I acknowledge that my entry fee is non-refundable, even if the Activity is cancelled.

### **Release and Indemnification Agreement for Injuries to Undersigned**

Participant agrees that he or she will assume complete and absolute responsibility for all known and unknown risks associated with the Activity, including but not limited to any injuries (including death) and property damage which the undersigned may sustain or cause as a result of the Activity. Participant agrees to release and indemnify, and agrees not to sue Event Sponsor or its Participants, the City of Green Bay, the Brown County – Green Bay Professional Football Stadium District, the Village of Ashwaubenon and their respective agents, assigns, owners, corporate subsidiaries, affiliates and parents, officers, directors, or insurers, from any actions, suits, damages, claims, or judgments (including attorney's fees and court costs) that may result from any personal injury or property damage which the Participant may sustain while participating in this Activity, even if the injuries or damage are caused by the negligence of Event Sponsor or its Participants, the City of Green Bay, the Brown County – Green Bay Professional Football Stadium District, the Village of Ashwaubenon and their respective agents, assigns, owners, corporate subsidiaries, affiliates and parents, officers or directors. This release of liability shall be a full and final compromise and settlement of any claims for any injuries suffered by the Participant as a result of the Activity.

### **Indemnification Agreement for Injuries Caused to Others**

In addition, Participant further agrees to indemnify Event Sponsor and its Participants, the City of Green Bay, the Brown County - Green Bay Professional Football Stadium District, the Village of Ashwaubenon and their respective agents, assigns, owners, corporate subsidiaries, affiliates and parents, officers, directors, and insurers, from any and all actions, suits, damages, claims, or judgments that may result from any personal injury or property damage which any other persons may sustain as a result of the Participant's conduct during or relating to the Activity.

### **Photo Release**

Participant further authorizes the Event Sponsor and anyone authorized by them, to retouch or alter any photographs, video, and audio taken of the event Participant and use it, in whole or in part, with or without the Participant's name, signature, and/or biographical information (including but not limited to city and state of residence) or other identification of any other fictitious or real person, in any and all media, for advertising or commercial purpose, and to claim and register its copyright in same; and further, release the Event Sponsor, and their respective employees, directors, officers, agents, successors, and assigns from any and all liability arising from the use of the Participant's photograph and from any blurring, distortion or optical illusion which may occur or be produced, as well as from the use of the Participant's name, signature, and/or biographical information; and further relinquish all right, title and interest in and to the negatives and prints and their reproduction, including the right to approve their final form, context and use.

### **Other Provisions**

You consent to medical care and transportation in order to obtain treatment in the event of injury to you or minor Participant and understand that this Agreement extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency and/or injury. You understand that no medical care may be available, but if it is, you assume liability for any and all medical expenses incurred as a result of your participation in the Activity (where such medical expenses are not provided on a free of charge basis by any medical services organizations, clinics, or hospitals), including, but not limited to ambulance transport, hospital stays, physician, and pharmaceutical goods and services. You agree to observe and obey all posted rules and warnings, to follow any instructions or directions provided to you by Event Sponsor and to abide by any decision of any Activity official relative to your ability to safely participate in or attend the Activity. You understand and agree that you are expected to exhibit appropriate behavior at all times while at the Activity and to obey all applicable laws while participating in or attending the Activity. This includes, generally, respect for other people, equipment, facilities or property. You agree that Activity officials may dismiss you, without refund, should your behavior, in the opinion of the Activity organizer, endanger the safety of or negatively affect the Activity. You understand and agree that you are responsible for taking care of your own personal belongings during the Event and, to the maximum extent permitted by law, Event Sponsor is not responsible for any personal item or property that is lost, damaged or stolen at the Event. In the event any section of provision of this Agreement is held to be illegal, invalid or unenforceable by any court, such holding shall not affect the validity of the Agreement's remaining sections or provisions.

NOTHING IN THIS AGREEMENT SHALL BE CONSTRUED AS LIMITING OR EXCLUDING ACTIVE'S OR THE EVENT SPONSOR'S LIABILITY FOR: (A) DEATH OR PERSONAL INJURY CAUSED BY GROSS NEGLIGENCE; (B) FRAUD OR FRAUDULENT MISREPRESENTATION; OR (C) ANY OTHER MATTER FOR WHICH IT WOULD BE ILLEGAL OR UNLAWFUL TO EXCLUDE OR ATTEMPT TO EXCLUDE LIABILITY. YOUR STATUTORY RIGHTS AS A CONSUMER ARE NOT AFFECTED BY THIS AGREEMENT.

### **Statement of Understanding**

I agree that I have read and understand this Release of Liability and Indemnification Agreement, and enter into it on behalf of me and my family, spouse, heirs, executors and assigns, anyone acting on my behalf, including attorneys, agents, insurers and representatives. I also acknowledge that I have had sufficient time to read this Agreement, and have had the opportunity to consider the consequences of signing this Agreement. I hereby represent that I am 18 years of age or older, or if applicable, that I am the parent or legal guardian of the child under the age of 18 years old who I am registering for the Event and that I have full power and authority to agree to these terms on behalf of such child, and to bind him/her to these terms.
